Entries

All entries must be made by using the BWF Online Entry System.

Entries must be submitted no later than Tuesday August 13th 2019 at 23.59 BWF HQ time (GMT +08.00).

Players can not be entered unless they already have a BWF ID-number. In case you wish to enter players who do not have a BWF ID-number, please contact the BWF office well in advance of the tournament, so that the players concerned can get a BWF ID-number before the closing date of the tournament.

It is required that every event in a particular BEC Circuit tournament has at least 8 competitors (i.e. actual competitors, not merely entries). If the required number of competitors is not met, this particular event shall not count towards any ranking. In accordance with regulation 10.5 in Appendix 6 to BWF's General Competition Regulations, an event must contain at least one entry from a Member Association other than the hosting Association. If an event does not contain at least one entry from a Member Association other than the hosting Association, this particular event shall not count towards any ranking.

Compliance with GCR 7.9: "In making or authorising entries, the Member concerned is reconfirming its acceptance, and acceptance by the Players being entered, of the BWF's regulations and Disciplinary processes."

Entry deadline Tuesday, August 13th 2019 at 23.59 BWF HQ time (GMT +08.00). No late entries will be accepted.









Entry fees Singles: 55 euro per player

Doubles: 50 euro per player per event

The Member Association that enters a player into a BEC Elite Circuit tournament is responsible for paying the entry fees for that player. The entry fees become due if a player is entered and has not been withdrawn when the entry deadline passes. The entry fees will not be refunded in the case of a withdrawal.

Entry fees for all players must be paid by the Member Association before August 29th 2019. The invoice for all players will be sent by e-mail on August 20th 2019. If no payment has been received, the invoice and original entry will be sent to BADMINTON EUROPE. Every unpaid invoice for entry fees sent to BADMINTON EUROPE shall result in an additional administrative fine of 100,00 EUR for the Member Association who is addressed in the invoice.

It is mandatory that partners in doubles wear the same colour of the T-shirt and shorts/skirts at all time during play in both the qualification and the main draw. Failing to do so shall result in an administrative fine of 100,00 EUR.

Prizes will be paid in cash in euros at the prize giving ceremonies or after the players' last match in the tournament. 18% domestic tax will be deducted.

Withdrawals

Please ensure that the Organizer is informed immediately when a player has to withdraw, preferably together with the reason.

Attention: any withdrawal after Monday August 26th 2019, for any reason whatsoever, renders the Members Association concerned liable to an amount of US\$ 150 for the inconvenience caused by the withdrawal (as defined in the BWF statutes 2.5).

No shows

Any player not showing up at the tournament, without having been withdrawn in advance, renders the Member Association concerned liable to an additional amount of US\$ 500,00 for the inconvenience caused by the "no show" (as defined in BWF GCR).

Cancellation

The organising Member Association can cancel a tournament in case of force majeure. Such cancellation must be announced at least 15 days before the start of the tournament. If a cancellation is announced less than 15 days before the start of the tournament, then the Member Association organising the tournament is liable for any expenses incurred by third persons (players, coaches, umpires, team managers etc.). BADMINTON EUROPE is not liable for any costs incurred by third persons because of a cancellation of a tournament. (article 3.4 in Badminton Europe Elite Circuit Regulations)









Badminton Integrity

There will be betting on offer from this event.

Section 2.4 of the BWF Statutes (Code of Conduct in Relation to Betting, Wagering and Irregular Match Results) relates to anti-corruption and antimatch manipulation, and this code applies to all participants at this tournament.

To protect the integrity of BWF sanctioned tournaments, participants are not allowed to bet in any way on badminton matches, respect the principle of fair play, and shall not attempt to influence the course or result of a game or match.

Every person has an obligation to report to the BWF any approaches by anyone to gather inside information or to change the outcome of a matches.

Condition of play

The tournament will be played in full accordance with the Laws of Badminton (BWF statutes 4.1) and the Competition Regulations adopted by the BWF as well as the Badminton Europe Elite Circuit Regulations.

Competitors must be prepared to play at the times determined for the events for which they have entered. Competitors will be scratched if not ready to play when called.

Players shall not plan their departure less than 2 (two) hours after their last match is planned to conclude. If a player is unable to compete due to early departure, he/she will be penalised by removal of Elite Circuit ranking points and shall not be awarded prizes or prize money. BADMINTON EUROPE shall propose to BWF that the gained BWF ranking points are also removed. (article 9.5 in Badminton Europe Elite Circuit Regulations)

There is a warming—up court in a signposted room at the tournament venue.

Athletes are responsible for any substance found in their body. Before an athlete takes any medication, they should check with their doctor, and if necessary, get a Therapeutic Use Exemption (TUE).
